

ClenoraHudson, PhD, Professor, Theorist, Producer, Film Writer, and Author of Africana Womanism: Reclaiming Ourselves (1993); Africana Womanist Literary Theory (2004); Africana Womanism and Race and Gender in the Presidential Candidacy of Barack Obama (2008-9); Emmett Till: The Sacrificial Lamb of the Civil Rights Movement (1994), from her Doctoral Dissertation (1988); The Definitive Emmett Till: Passion and Battle of a Woman for Truth and Intellectual Justice (2007) and editor of Plagiarism—Physical and Intellectual Lynchings: An Emmett Till Continuum (2007). Hudson was interviewed on her groundbreaking "Emmett Till" and "Africana Womanism" works by *The* American Audio Prose Library (1995). Coauthor of Toni Morrison (1990), she is also editor of Contemporary Africana Theory, Thought and Action: A Guide to Africana Studies (2007).

A recipient of numerous honors and awards, including Ford Fellowships, National Endowment for the Humanities, the CIC Internship, Proclamations, and Keys to Cities, she and co-author, Dr. Wilfred D. Samuels, received a 1998 Toni Morrison Society Book Award for *Toni Morrison*, the 1st book on this Nobel Prize-Winning author. Clenora served as National Chair for several Till Conferences, and was a distinguished Honoree for the 1st International Africana Womanism Conference, hosted by the U of Zimbabwe (Africa) in 2010. She wrote the Till film script.

## Emmett Legacy, Redemption and Forgiveness

The first to establish the 1955 brutal lynching of 14-year-old Emmett Louis Till as the true catalyst of the Modern Civil Rights Movement of the 50s and 60s was Clenora Hudson to whom God Almighty gave the vision. Here she offers a complete interpretation of the naïve act of this Black Chicago youth--whistling at a 21-year-old white woman, Carolyn Bryant, in Money, MS. An American taboo, it ultimately sparked a Movement that indelibly impacted many, forever altering American culture, both socially and politically. People abroad, too, were impacted upon, as they were astounded by the lynching of an innocent child. With Till as a cause célèbre, one shocked European inquirer asked, "ARE YOU FROM THE LAND WHERE THE BOY WAS KILLED?"

In challenging the Academy in her persuasion to make Emmett Till the subject of her 1988 Ford Doctoral Dissertation, Clenora details the powerful pervasive facts that impacted so many. His mother, Mamie Till, made a lifetime commitment to her only child to change racist minds and laws in America with the help of God. Rayfield Mooty, a Labor Union leader, Civil Rights Activist and Mamie's second cousin, vowed to support her as her advisor, thus, becoming the supreme strategist. Finally, there was the Spirit of Redemption, Atty. John Whitten, Jr., who delivered the closing remarks for the defense. He evolved from a racist to a remorseful sympathizer, subsequently spending his life representing poor Blacks in the state of Mississippi "pro bono" as an act of atonement, indeed, an exemplar for correcting racist attitudes and acts.

As victimization and racial healing unfold, we hear the stories told through the eyes of these four main characters, attesting that the true ugliness of racism, symbolized by Emmett's bloated face, must be eradicated. Racism is not a benign phenomenon, but rather a toxic malignancy, waiting to be purged from our hearts and souls forever. With that, America can be what it was originally intended to be when the first immigrants landed upon these shores from foreign lands. This, even now, could bring about a long awaited racial healing, thereby rendering our world one less battle to endure. Indeed, the universality of racism and racial healing through God's blessings reigns high!
